The Contractor further covenants that in the performance of this Contract, no person having any such interest shall be employed.

Records and Audits

The Contractor shall maintain accounts and records, including personnel, property and financial records, adequate to identify and account for all costs pertaining to the Contract and such other records as may be deemed necessary by the Government Authority to assure proper accounting for all project funds. These records will be made available for audit purposes to the Government Authority or any authorized representative, and will be retained for three years after the expiration of this Contract unless permission to destroy them is granted by the Government Authority.

Most Responsible: Includes, but is not limited to:

- Contractor's financial position, including property, city, state and/or federal tax status, delinquent taxes may be a reason for disqualifying a contractor
- Current and/or past tax foreclosures
- Current and adequate insurance
- Current Ohio workers' compensation
- Adequate bid bond meeting all requirements of bid specifications
- Judgment liens
- Past and present law suits
- Safety records
- OSHA violations
- EPA violations
- Known experience
